Among these so-called fringe benefits are paid holidays, vacations, insurances, pensions, recreation, overtime, shift extras, social security, unemployment compensation, and others. The costs for all these benefits are not known, because the individual does not actually receive the money that most of

But each individual should know the amount that they do cost. Here at the Waterbury Division the cost to the Company of these fringe benefits amounts to 67.3 cents per hour per employee based on a 1,750 hour work year.

That ain't hay! It is a substantial part of total compensation for working.

SERA Calls Special Membership Meeting










At left is the pair of damaged safety glasses which saved the sight recently of Joseph Salerno, General Training. Joe has good reason to smile.

There's always a better way. Even with the most modern equipment and facilities available, there can be room for improvement.


